Minimum Orders:

Our opening order requirement is \$200 and our minimum reorder is \$100.

Payments:

Payments may be made by credit card, check, or money order. Orders from overseas must provide a 20% deposit via wire transfer.

Policies:

The Babee Greens™ Client Information form must be completed including a valid Federal Tax ID # before placing an opening order.

Online auctioning of new Babee Greens™ products is not permitted .

Co-op sales are not allowed.

Shipping:

All items will be shipped via UPS ground unless other arrangements are made. Items are generally shipped within 1 week or less from order date.

All packages are assigned with tracking.

Customer must provide additional insurance if requested.

Babee Greens™ cannot be responsible for lost or damaged items during shipping.

Return Policy:

Items may be returned for credit towards future purchases. There is a restocking fee of \$1 per item. Items must be in new, unwashed condition. We cannot give credit towards items that have been washed, items that smell of essential oils / perfumes or smoke, or items that have been soiled. Flawed items will be credited 100% of the purchase price. We guarantee work for 60 days from purchase date. All returns on defects must be accompanied by a copy of the invoice from the customer's purchase. We offer a lifetime guarantee on our snap hardware.
